_____ (initial) TERMS

- All drop offs are by appointment only and will be inspected and sorted during appointment. All clothing must be dropped off in a tub with lid preferably with name and consignor # clearly visible/marked. (Please no bags) Please make sure items have been freshly laundered, wiped down and are free of holes and or stains to the best of your ability. Kids Corner Consignment will establish and set the pricing on all consigned items. We will always strive to secure the best possible price for your item based on manufacturer, quality, condition and marketability of the piece. • Sales and promotions will take place as follows: 30 days or more (30% off), 60 days or more (50% off), 90 days or more the items must be picked up or surrendered, becoming Kids Corner's property. This will keep inventory fresh and moving.
- Items will be accepted for a 90 day consignment period, starting from the day that they are priced and placed on the sales floor. Holiday items will have a 60 day consignment period and follow a 20/40/60 percent markdown every 15 days • There is a ONE TIME ONLY account registration fee of \$10 to establish and maintain your account. This is due now and payable at the time of signing up. All consignment items must be clean, include batteries, in displayable condition and ready for resale. Kids Corner Consignment may charge a fee up to \$25 if items require additional cleaning or repair; including, but not limited to installation of batteries. The cost of this work, if necessary, will be deducted from the consignors account.
- All items consigned with Kids Corner Consignment will remain the property of the consignor until the 90 day mark. While all reasonable efforts will be made to keep consigned items clean and safe from damage; Kids Corner Consignment is not responsible for LOSS or DAMAGE to consigned articles from fire, water, theft, damages or other casualty.

_____ (initial) COMMISSION • I understand my share is 40% of the final selling price for items sold within the 90 day consignment period. • My store credit will be issued and available in my account immediately once the item is sold. Up to 50% of my store credit may be used for any sale in the store during each visit, but if I want to cash out my account, I will be issued a check for 50% of store credit balance and account will be settled.

_____ (initial) UNSOLD ITEMS • If you wish to retrieve your unsold items, you must do so within 5 days of the end of the consignment period. Please mark your calendar and monitor your account as Kids Corner Consignment does not call to notify of unsold items. You are welcome to contact us and request a copy of sold/unsold items through e-mail at kidsccshop@gmail.com. We retain the right to sell or donate those items if they are not removed by the consignor or his designated representative within the 90 day period.

_____ (initial) PAYMENTS: Store Credit will be available in consignors account immediately upon sale of items. If consignor requests cash and settling of account, store credit at a 50% rate then this can be requested on or following the 15th of the month. Account must be settled at shop and only one check can be requested per month.
